Reply received from Wiltshire Council clarifying planning procedures under the new Authority.

- a) Parish Councils may submit arguments on planning grounds through another Councillor in the absence of their elected Councillor.
- b) In the event that the elected Councillor disagrees with the Parish Council's arguments the call in powers rest with the Councillor unless the proposal is of significant interest to the wider community.
- c) Existing practices for consultations will not change. A review will be undertaken in 2010, when data will be available regarding the number of councils participating in electronic consultation.
- d) Planning Officers will continue to screen letters etc to ensure that nothing inflammatory is published.

Upgrade of Sewerage Treatment Plants.

Selwood Housing has notified residents of The Grove that it is planned to upgrade the Treatment Plant and the projected costs would entail a contribution from the owner occupiers in the region of £6000.00 per household. New Road residents have joined with The Grove and formed a representative Committee, in association with other villages, to negotiate with Selwood regarding the proposed contributions. The PC is fully supportive of the Committee's aims.

Cllr.Newbury informed that he had written to the Chief Executive of Selwood to remind him of the original handing over arrangements of the treatment plants from the District Council and also to protest at the tone of the letter to residents.

9. Matters to Report

Mrs Wyeth reported that a loose association of Chairmen of Parish Councils in the Wylye Valley had been formed and any issue of common interest would be approached as a joint venture.

Merger Committee.
